Whereas, this office vide Order No: 402-DSEJ of 2015, Order No.403-DSEJ of 2015 and Order No.405-DSEJ of 2015 dated: 11-7-2015 issued the transfer/postings Orders of Lecturers, Masters and Headmasters, respectively, and;


Whereas, this office received representations from some officials that they have not completed their minimum stay at present place of posting, and ;

Whereas, the aforesaid orders were kept in abeyance vide this office No. DSEJ/Gen/12946-14200 dated 14-07-2015 , and ;

Whereas, this office enquired the matter and after delving the issue in depth it came to the notice that Smt. Karuna, Master CHS Udhampur existing at Sr. No.41 from District Udhampur and Smt. Rekha Kohli, Master MS Sunderbani, existing at Sr. No. 24 from District Rajouri are premature cases in Order No.403-DSEJ of 2015 dated. 11-7-2015 as they have not completed the minimum stay, and ;

Whereas, a reprimand was issued to Chief Education Officer Udhampur and Rajouri with the instructions to ensure that the staff statement in future is verified and validated personally before submission to the Directorate.

Therefore, Order No.DSEJ/Gen/12946-14200 dated: 14-7-15 is hereby withdrawn and Order No. 402-DSEJ of 2015, No.403-DSEJ of 2015 and No.405-DSEJ of 2015 dated: 11-7-2015 kept in abeyance are restored with immediate effect except for S.No. 24 and S.No.41 in Order No. 403-DSEJ of 2015 dated: 11-7-2015, who shall continue at their present place of posting. All the transferees in aforesaid orders are directed to report to their new place of posting immediately. The Chief Education Officers of Jammu Division are instructed to furnish the compliance report of implementation of these orders within seven days positively.
