
Whereas, this office vide order No. 422-DSEJ of 2015 dated: 29-7-2015 , directed all unadjusted/surplus Lecturers and Masters to report to concerned Chief Education Officers, and,

Whereas, vide the aforesaid order the unadjusted/surplus Masters and Lecturers were directed to report to the concerned Chief Education Officers within 24 hours, and;

Whereas, Administrative Department vide order No. 327-Edu of 2015 dated: 10-7-2015 issued detailed instructions to improve personnel administration and directed all the transferees to join the new place of posting within the stipulated time without waiting for decision of representation of modification, However, it was directed that those who suffer from life consuming diseases or in whose cases there is an existing Standing Medical Board recommendation, may continue at their previous place of posting provided they submit a representation to the concerned Director within three days , and ;

Whereas, it has been observed that in clear violation of CCA Rules , Govt. Order No. 327-Edu of 2015 dated: 10-7-2015 and directions issued by this office many of the Masters and Lecturers have not complied the transfer/posting orders issued by Administrative Department.

Now, final opportunity is given to all such Masters/Lecturers who have failed to report to concerned Chief Education Officers in pursuance to this office Order No 422-DSEJ of 2015 dated: 29-7-2015 with the directions to report to the concerned Chief Education Officer by or before 17-8-2015, failing which they shall be treated as absent from duty in terms of Article 128 of CSR and shall be deemed to be placed under suspension. The concerned Chief Education Officers shall after compilation of information ensure same is submitted to this Office by or before 19-08-2015 positively. (Performa enclosed).
