
Sub: Village level consultations of New Education Policy (NEP), organizing of the meetings and uploading of the data thereof: -

CIRCULAR NO: 586-DSEJ OF 2015
DATED: 28-10-2015

I am directed to instruct all the Chief Education Officers to ensure that the village level consultation meetings through the Village Education Committees constituted in pursuance to Govt. Order No. 272 dated: 12-06-2015 is held across all the districts on **1st November 2015 (Sunday)**, on the themes regarding policy consultation on school education (the list of themes and model questions enclosed for reference). The VEC's shall deliberate on these themes and the concerned chairperson shall ensure that proceedings of these meetings are properly documented.

Furthermore, the Joint Director (Trainings) / Principal S.I.E is appointed as Nodal Officer at provincial level to supervise the organizing of these VEC meetings and uploading of the data by **4th of November , 2015**. The Joint Director Trainings shall assign duties to respective Principal DIET's who shall work in tandem with the CEOs at District level. The Principal D.I.E.T concerned shall further assign duties to all HOD's at Zonal level.

The Chief Education Officer of the concerned district shall be the Nodal Officer at district level and shall ensure that all the ZEOs and the Cluster Heads of the schools are actively involved in the organizing of these VEC meetings and that documentation of these meetings is properly done. It shall be the personal responsibility of the Cluster Head concerned that the outcome of the consultations is uploaded on the website of the Ministry of Human Resources, GOI. The login ID for the purpose shall be obtained from the District Informatics Officer of the concerned district and it has to be ensured that the uploading is completed by **4th November**. Furthermore, it has to be also ensured that the list of themes and model questions is made available immediately to concerned chairpersons of the VEC's who shall after thorough comprehension , further ensure that deliberations of VEC meetings are interactive, cordial, nimble and that all the suggestions are recorded properly. The Chief Education Officer concerned shall prepare a discussion paper on the basis of these village level consultations. The data at district level shall be analyzed by a committee of officers headed by the Chief Education Officer and also comprising the Principal DIET , ZEO and

the Cluster Head concerned. The district level consultation meetings shall be held under the chairpersonship of respective Deputy Commissioners. The Chief Education Officers shall immediately solicit instructions for smooth implementation of the programme from the Deputy Commissioner concerned. The district level meeting in this regard shall be held on **9th of Nov. 2015**. The Chief Education Officers shall ensure outcome of the district level consultations is uploaded by **12th November, 2015** on the website.

The CEOs shall ensure detailed compliance report from each district along with the requisite photographs is submitted to the directorate.
