Sir,

Hon'ble Chief Justice of India and Hon'ble Executive Chairman,NALSA have desired that the National Lok Adalat for all matters may be organised throughout the country right from Taluk level court to Supreme Court on 12th Dec.2015.

In this regard, the J&K High Court Legal Services Committee(J&KHCLSC) shall organise National Lok Adalat on 12th Dec.2015 in both the wings of the Hon'ble High Court Srinagar and Jammu.

I am under directions of Hon'ble Mr. Justice Hasnain Masoodi, Judge, High Court of J&K, Chairman J&K High Court Legal Services Committee, to request you to direct all the Heads of the department (HODs), to identify the cases i.e. SWP Matters and OWP Matters that are presently pending before both the wings of Hon'ble High Court Srinagar and Jammu and that can be taken up and settled through negotiation, mediation, arbitration or conciliation in the National Lok Adalat on 12th Dec.2015, and transmit the list of cases to this Committee at Jammu wing of the Hon'ble High Court by or before 30th Oct. 2015, for placing the same before His Lordship Hon'ble Chairman, J&K High Court Legal Services Committee.The Pre-Lok Adalat sessions for these cases shall be held in 3rd week of November,2015.

You are also requested to ensure the presence of representatives/standing counsels of their respective departments in the Pre-Lok Adalat sessions and National Lok Adalat on 12th December,2015. The Time and Venue of the Pre-Lok Adalat sessions and National Lok Adalat shall be in the High Court complex Srinagar/Jammu at 10.00 A.M. sharp.
