Whereas, vide Government order No:438-Edu of 2015 dated: 27-08-2015, the following newly promoted Master/Teachers were promoted as I/C Lecturers in the discipline of Environment Science and;


Whereas, vide this office letter No: DSEJ/GAZ/Lect/21601-09 dated:29-08-2015, they were directed to report to this office for verification of documents and further reported to their School subject to settlement of their adjustment by Adm. Department in pursuance to circular No: Edu/Gen/71/part/2015 Dated 03-08-2015 and ;

Whereas, vide order No: Edu/Gen/71/2015/2015 Part dated: 26-11-2015 the Adm. Department conveyed the approval for their transfer/adjustment as per requirement.

Now therefore in view of the requirement expressed by various Schools/Principals and CEO's the order for their adjustment is hereby issued as shown against each as per Annexure -A with immediate effect subject to the fulfillment of the following conditions:-

The promotes shall report to their respective places of posting within a period of 21 days from the date of issuance of this order, failing which their promotion shall be forfeited and benefit of in-situ promotion, if any availed by the promotee shall be treated as withdrawn . Before allowing the newly promoted I/c Lecturers to join, the Drawing and Disbursing Officers shall ensure :-

- 1 That any of the official, who has already been working either as I/C Lecturer in any other discipline may not be allowed to join as I/C Lecturer (EVS.).
- 2 That the mode of acquiring degree (i.e. 10+2+2) with bridge course or (10+2+3) as well as the genuiness of P.G. degree certificate /institution from which acquired are valid and validity of category certificate(s), if any, shall be determined by the concerned DDO.
- 3 That the DDO shall take an undertaking in the shape of an affidavit duly attested by 1st class Magistrate from the concerned I/C Lecturer to the effect that if his/her service particulars /PG certificate is proved fake/forged/tampered or issued by un-recognized University /study centre/off campuses which has been established by the State University beyond their territorial jurisdiction, he/she shall have no claim for elevation and the elevation order issued in her favour be treated as cancelled ab-initio without any further notice.
- 4 That the I/C lecturer is not involved in any adverse case(s) (Vigilance/Crime etc) shall be ascertained by the concerned DDO.
- 5 That the I/C lecturer has acquired P.G. Degree after availing the leave during the studies with due authorization and after obtaining proper permission from the competent authority.
- 6 That this order is issued without prejudice to the final outcome of the writ petition(s), if any, pending in any court of law and other conditions laid down in the above referred Govt.order


