Matter Most Urgent

It has been observed that some of the Lecturers/Masters appointed as Superintendents/Dy. Superintendents for conduct of JKBOSE (SSE class 10th) and Higher Secondary Examination (12th) Summer/Winter Zone of Jammu Division refuse to co-operate with JKBOSE in smooth facilitation of Examinations. Such an act amounts to the violation of Rule 3 of JK Govt. employees conduct rules.

As such, it is hereby impressed upon all the Chief Education Officers to inform all employees of Education department, who are on deputation to JKBOSE for examination duties, that departmental action under CCA rules shall be initiated against them, if a compliant of misconduct is received against them.

The controlling officers are also required to ensure compliance of their staff for BOSE duties.
