Sub: Adjustment of surplus Masters.

Whereas the Chief Education Officer Jammu vide No. CEOJ/28953 dated: 19-01-2016 has reported that the following Masters were attached in his office on medical grounds suffering with life consuming diseases of self/dependent, and;

Where as in pursuance of Govt. Order No. 622- Edu of 2015 dated. 22-12-2015 (Para-13) of it provides as under:-

“For transfer on medical grounds of self, spouse or dependenty children, the recommendations of the standing Medical Board would be pre-requisite. The Board shall clearly record the severity of disease and the concessions required to be granted, if any, with reference to the Medical condition. The Medical Board shall also keep in view the general stage of improved medical facilities in the state as also the disease management techniques, particularly with regard to lifestyle diseases. The recommendations shall be valid only for two years and if any continuation is required, fresh certification will be necessary. However, in respect of life consuming/terminal disease of the official, no fresh certification shall be required”, and;

Whereas in pursuance of Govt. order No. 327-Edu of 2015 dated. 10-7-2015 (para-2) of it provides as under:-

“who suffer from life consuming diseases or in whose case there is an existing Standing Medical Board recommendation, may continue at their previous place of posting provided they submit a representation to the concerned Director within three days who shall forward the same, with their comments, within a week to the Administrative Department from the date of issuance of the transfer order”, and;

Whereas in pursuance of the Govt. Order No. 26-Edu of 2016 dated. 2-2-2016 (Para-ii) of it provides as under:-

“Officials rendered surplus on account of various reasons shall immediately be posted by the concerned Directorates with due consideration of the transfer policy of the department”

Now, therefore, in view of the transfer policy and the Government Orders referred above, the following surplus Masters attached in the office of Chief Education Office Jammu are hereby adjusted with immediate effect.
