Sub: Adjustment of surplus Masters.

Whereas the Chief Education Officer Jammu vide No. CEOJ/28953 dated: 19-01-2016 has reported that the following Masters were attached in his office on medical grounds, and;

Whereas in pursuance of Govt. Order No. 622- Edu of 2015 dated. 22-12-2015 (Para-13) of it provides as under:-

"For transfer on medical grounds of self, spouse or dependenty children, the recommendations of the standing Medical Board would be pre-requisite. The Board shall clearly record the severity of disease and the concessions required to be granted, if any, with reference to the Medical condition. The Medical Board shall also keep in view the general stage of improved medical facilities in the state as also the disease management techniques, particularly with regard to lifestyle diseases. The recommendations shall be valid only for two years and if any continuation is required, fresh certification will be necessary.", and;

Whereas in pursuance of Govt. order No. 327-Edu of 2015 dated: 10-7- 2015 (para-2) of it provides as under:-

"In order to improve personnel administration as also ensure proper staffing in the schools", and;

Whereas in pursuance of the Govt. Order No. 26-Edu of 2016 dated. 2-2-2016 (Para-ii) of it provides as under:-

"Officials rendered surplus on account of various reasons shall immediately be posted by the concerned Directorates with due consideration of the transfer policy of the department"

Now, therefore, in view of the transfer policy and the Government Orders referred above, the following surplus Masters attached in the office of Chief Education Office Jammu on medical grounds are hereby-adjusted with immediate effect in the schools as shown against each as per **Annexure-A** of this order.

Further, the Masters are deemed relieved and directed to report to their new places of posting within three days failing which action as warranted under rule shall be taken.
