Subject:-Transfers/postings of Lecturers from/to the districts of Leh and Kargil.

Government Order No. 84-Edu of 2016
D a t e d : 14-03-2016

Sanction is hereby accorded to the:-

- (i) transfer/posting of 18 Lecturers of Zoology and Botany disciplines to Leh and Kargil Districts forming Annexure "A" and "B" to this order.
- (ii) repatriation of Sh. Shakeel Ahmad I/C Lecturer, Botany from Leh. He shall report to his respective Directorate of School Education for further posting / adjustment.

While affecting such transfers, due care has been taken that these are in accordance with Transfer Policy for Leh/Kargil districts issued vide Government Order No. 20-LA of 1999 dated 16.06.1999 read with amendments thereafter, and the junior most promotees/direct recruits are posted to Ladakh/Kargil.

The transfer is further subject to the following conditions:-

- a) The concerned HOD(s)/Principal(s) shall relieve all the transferee within a period of 03 days, failing which the transferee shall be deemed to have been relieved from their places of postings and join their new place of posting within the stipulated period. Otherwise, action under rules shall be taken against those who fail to join their places of postings without any further notice which may include withdrawal of elevation.
- b) the present DDO shall not draw the salary of transferee. Any departure from the same would be treated as dereliction of duty on the part of DDO concerned, making him liable to disciplinary action.
