Upon review of attachment/deployment of staff in terms of Govt. order No;26-Edu of 2016 dated 02.02.2016 and compliance thereof, it is clarified and in supersession of previous orders thereto, it hereby ordered that salary shall be drawn/regulated from the overall cadre strength of +2 lecturers, Jammu Division as under:-


**Category-"A"** (up to January, 2016)

- a) Incumbents posted but could not join due to non-availability of post, hence surplus and awaiting orders of adjustment.

**Category "B"** (up to February, 2016)

- a) Surplus Lecturers Posted in month of February 2016 on vacancies or posted, keeping in view of the roll of the subject in the institution but without post.  
b) Incumbents posted but continuing at the previous place of posting as per the directions of the Hon'ble High Court.

The concerned Drawing and Disbursing Officer besides ensuring strict adherence to codal formalities, shall also ensure that salary is released after proper verification on case to case basis and that salary is released only in respect of those officials who fulfill the criteria as mentioned above/have ensured compliance of posting/adjustment orders issued by Administrative Department/this office.


**Sub:- Release of Salary in favour of the Surplus Lecturers**

**ADDENDUM TO ORDER NO.921 DSEJ OF 2016 DATED 27-02-2016**

Adm. Dept. vide communication No. Edu/PS/DS/2016 Dated:12-02-2016, inter alia has directed as under:-

- Wherever an official has been detached and directed to report to a subordinate office, the official should be posted further to a school positively by 13.02.2016(A.N).
- Wherever an official has already been posted to a school, he/she should join in that school immediately. Non-compliance be reported by 15.02.2016.
- Wherever any of these officials have been issued duty slips (since their posting) by the Directorate/CEOs/ZEOs, date wise detail with name and purpose be furnished by 15.02.2016 (A.N). The DDOs are instructed not to draw the salary of any official where duty slips have been issued for more than 5 days in a month, till further orders in this regard.

In view of the above, salary of the surplus lecturer(s) shall be released up to Feb-2016. However, after 12.02.2016 instructions of Adm. Deptt. be strictly adhered in letter and spirit. Other terms and conditions of the Order No. 921 DSEJ of 2016 dated:27-02-2016 shall remain un-changed.
