Whereas, SRO-272 dated 19.09.2008 it is provided as under:-

"Head Assistant: Provided that 25% of posts to be filled up in a calendar year shall be earmarked for promotion of those Senior Assistants who have not qualified the Secretariat Assistants Examination but have crossed the age of 50 years as on  $1^{\mathrm{st}}$  January of the calendar year in which such promotion are being considered."

Whereas, time and again representation has been made by the I/C Head Assistants for their regularization/confirmation.

The aforesaid order shall be further subject to the following terms and conditions:-

- That the work and behaviour of the officials has remained satisfactory. i)
- That there is no case against the officials pending in the Vigilance. If there is any such case against the officials, his/her promotion may not be effected. ii)
- That the said officials have rendered uninterrupted service in the existing iii)
- That in case official is holding non-functional pay scale higher than that the functional scale, the pay and scale shall remain the same to avoid loss of pay iv) drawn by such official in the non functional higher scale.
- The confirmation of the official shall be without pre-judice to the superior V) claim of others if any.
- The benefit of confirmation shall not be allowed in case the official is under suspension or against whom departmental proceedings are pending/ vi) undecided.
- The official must necessarily hold genuine appointment on substantive basis and un-interupted service and shall not be involved in fake, fraud, advii) hoc/contractual appointment and are not subject to any criminal proceedings.

In case any incumbent/official who is otherwise eligible for confirmation but his/her name has not been included in the aforesaid order inadvertently, he/she shall represent his/her case to the concerned DDO within 21 days who in turn shall forward his/her case to this office along with original service book of the employee and collateral records.
