Sanction is hereby accorded to the temporary appointment of Mr. Mohd. Shakeel Khan S/o Late Abdul Waheed Khan (Ex-Master), Govt. HS Marhote, Zone Surankote, R/o Village Kotian, Tehsil Mendhar, District Poonch as Class-IV (Lab. Bearer) in the Pay Level SL 1 (14800-47100) in the School Education Department in District Poonch under SRO-43 of 1994.

The appointee shall report to the Chief Education Officer, Poonch within a period of twenty one days from the date of issuance of this order and shall be allowed to join only on production and verification of the following documents/certificates;

1. Academic Qualification Certificate.
2. Date of Birth Certificate.
3. Domicile Certificate.
4. Health Certificate from the concerned Chief Medical Officer of the District.
5. Dependent Certificate issued by the Assistant Commissioner Revenue.
6. No Loan Certificate under Self Employment Scheme from DIC Concerned and Employment Department.
7. All other relevant documents as are required under SRO-43/1994.

The appointment of the appointee, shall further be subject to the following conditions:-

(a). That he/she shall give an undertaking in the shape of an Affidavit to the effect that:

(i). In case adverse report about his/her Character and Antecedents is received from the Inspector General of Police, (CID), J&K, to whom a reference shall be made that he/she shall have no right to Claim his/her appointment as Class-IV (Lab. Bearer) in School Education Department and his/her appointment, as such, shall deemed to have been cancelled ab-initio;

(ii). If, on verification, genuineness of the qualification certificates from the concerned issuing authority is found that the same is fake/forged, the claim of the appointee for appointment as Class-IV (Lab. Bearer) shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against his/her.

(b). The Salary of the appointee shall not be drawn and disbursed to him/her unless a satisfactory report in respect of (i) and (ii) above are received in his/her favour.

- (c).The appointee shall be initially on probation for a period of two years.  
(d).The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.  
(e). If the appointee fails to join within a period of 21 ( twenty one) days from the date of issuance of this order he/she shall forego his right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.

This order is, however, subject to outcome of writ petition if any, pending in any competent Court of Law.

If on verification, the certificates produced by the appointee are proved to be fake or forged, the appointment shall be cancelled abinitio.

The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report about the verification of his character and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by the Chief Education Officer, Poonch.
