Whereas, complaints have been received from parents regarding charging of exorbitant fee without the approval of competent authority, the parents are being forced to purchase school books (not prescribed by the authority) and stationery items from selective vendors at very high rates.

Whereas in order to verify the complaints teams were constituted by this Directorate vide Order No. 9525-38 Dated: 16.03.2019 and No. DSEJ/Pvt/14486-93 dated 20.04.2019 and the teams submitted their report to this Directorate.

Whereas these reports reveal that your schools have introduced books other than those prescribed by the competent authority i.e. CBSE/ NCERT & J&K BOSE upto Middle level which is violation of rules governing the permission/recognition/affiliation, you are also violating orders of Fee Fixation Committee regarding Fee Structure and orders of Hon'ble High Court as well.

Therefore, before proceeding further, you are hereby asked to explain your position within 03 days failing which necessary action as warranted under rules shall be initiated against you, which includes de-recognition
