Whereas, Chief Education Officer, Jammu vide letter No. CEOJ/Gen/SRO-43/59949-51 Dated:-22.02.2020 has submitted a compassionate appointment case of the Mr. Vikram Dev Singh Jamwal S/o Sh. Subash Singh Jamwal & Late Smt. Veena Slathia in terms of SRO-43 of 1994; and

Whereas, the applicant has applied for considering his compassionate appointment as teacher with qualification B.A. and one year Computer Diploma in lieu of death of his mother (died on 09.11.2001); and

Whereas vide this office letter No. DSEJ/NG/SRO-43/1073/11423 dated:-03.06.2020, Chief Education Officer Jammu was requested to clarify whether the said case has been rejected earlier or the applicant has applied earlier and his case is pending and not settled as yet. If the case falls in the category of pending/rejected cases then submit the requisite documents in terms of SRO-120 of 2018 ; and

Whereas Chief Education Officer, Jammu vide letter No. CEOJ/Gen/SRO-43/2574-76 dated:-05.06.2020 has furnished the information that the case falls in the category of pending cases; and

Whereas vide this office letter No. DSEJ/NG/SRO-43/1073/18997 dated:- 10.08.2020, Chief Education Officer Jammu was again requested to clarify whether the said case has been rejected earlier as the applicant has applied for compassionate appointment after a gap of nine years; and

Whereas Chief Education Officer, Jammu vide letter No. CEOJ/Gen/SRO-43/19500 dated:- 27.11.2020 has submitted that no application has been submitted by the applicant before 26.10.2019 as per school record of Govt. Girls Higher Secondary School Mubarak Mandi ; and

Whereas, in terms of SRO-43 of 1994 the applicant has to apply within one year from the death of the deceased person (his mother) and in terms of SRO-120 of 05.03.2019 only pending/rejected cases on the date of issuance to SRO Notification 120 of 2018 dated 05.03.2018, shall be decided in accordance

with the said notification. However, in the instant case neither the applicant has applied within one year from the date of death of deceased nor the said case falls in the pending/rejected cases on the date of issuance of SRO Notification 120 of 2018 dated 05.03.2018.

Now, Keeping in view of above facts and in terms of SRO-43 of 1994 the claim for compassionate appointment in favour of Mr. Vikram Dev Singh Jamwal S/o Sh. Subash Singh Jamwal & Late Veena Slathia (Ex-Lecturer) R/o Surinsar, Tehsil Nagrota, District Jammu is hereby rejected.
