ORDER No: 255-DSEJ of 2020

Dated: 13-06-2020

Sanction is hereby accorded to the placement of 20 Masters shown in the Annexure-A to this order as I/C Headmasters and equivalent in their own pay and grade for a period of six months or till clearance by Public Service Commission. They shall be entitled for charge allowance as admissible under rules. The placement is subject to the following conditions:-

- 1 That the placement will not confer any superior claim or right upon the promoted Masters and it shall be prejudice to the seniority of others. Moreover, the placement of incumbents as I/C Headmaster shall be operative only after physically joining the new assignment as shown in this order failing which it will be presumed that the promotee is not interested in availing the benefit of promotion and his/her promotion shall be cancelled without any notice and the candidates falling next in seniority shall be promoted.
- 2 That this orders is issued without prejudice to the outcome of writ petitions if any, pending before the Hon'ble Court of J&K /Apex Court and shall be subject to outcome of complaint/case, if any, pending before any statutory and constitutional body in respect of their service matters.


