- 5. All other relevant documents as are required under SRO-43/1994
- 6. No Loan Certificate under Self Employment Scheme from DIC Concerned and Employment Department.

The appointee shall be initially on probation for a period of two years. If on verification, the certificates produced by the appointee are proved to be fake or forged, the appointment shall be cancelled abinitio.

The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report about the verification of her character and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by the Chief Education Officer, Jammu.

This order is, however, subject to outcome of writ petition if any, pending in any competent court of law
