Whereas, online applications were invited for transfer of Headmasters having mature stay as provided in the existing transfer policy;

Whereas, vide this Office Order No 1094-DSEJ of 2019 Dt. 03-08-2019 Sh Sayed Ahmed at S.No 66 and Sh. Manohar Kumar at S.No 67, Headmasters were transferred taking into account the choice of posting mentioned by Sh Sayed Ahmed in online application form. The transfer and posting was made on the basis of service particulars including tenure at present place of posting as mentioned by the concerned in online application form and in the database provided by the Chief Education Officer, Kathua; and


Whereas, it was, later, found out that wrong entries had been made in the online application form of Sh. Sayed Ahmed and also in the database provided by the office of concerned Chief Education officer about the actual stay period of both these incumbents at present places; and

Whereas, Baldev Raj, Head Master, HS Panjar, Udhampur had also made wrong entry about his stay in the online Google form and he was also transferred vide Order No 1094-DSEJ of 2019 Dt. 03-08-2019 at serial number 54; and

Whereas, the existing transfer policy provides for minimum stay of two years and maximum stay of three years for transfers and postings; and

Therefore, in view of the above facts, it is hereby ordered that transfer and posting in favour of serial numbers 54, 66 and 67 in this office Order No. 1094-DSEJ of 2019 Dt. 03-08-2019 shall **stand cancelled ab-initio**. If the incumbents have joined at new places of posting, they shall revert back to their original places of posting.
