ORDER

Sub:- Constitution of Monitoring Teams on implementation of cancellation of Attachments and Deployments on academic rationalization basis.

Whereas, the Government vide Circular No:-22-GAD of 2018 dated 06-07-2018, ordered cancellation of all attachments; and

Whereas, after due deliberation the Chief Education Officers of Jammu Division have submitted full detail of attachments and their cancellation along with a certificate; and

Whereas, there are reports that in some cases the cancellation of attachments has not practically taken place which is a violation of the instructions; and

Whereas, the matter was discussed in detail in a high level meeting and a serious view of the aforementioned reports was taken and it was decided to get the factual positions ascertain through a three tier mechanism such as Joint Directors, CEOs and ZEOs levels.


