Whereas, vide this office order No: 1212-DSEJ of 2019 dated 02.11.2019, 74 lecturers in the discipline of English were transferred and posted while giving preference of choice posting to those who had applied online subject to merit and feasibility;

Whereas, it is a settled legal position that transfers and postings at places of choice cannot be claimed as a matter of right and these are essentially made in the interest of administration while taking into consideration individuals preferences in the light of guidelines provided in the existing transfer policy;

Whereas, without prejudice to the above legal position, the said transfer and posting order provided for review applications in case of any grievance;

Whereas, 27 number of applications were received which have been examined in detail and disposed-off on the basis of individual merit of each case subject to feasibility;

Whereas, some other transfers of lecturers having mature stay also have to ordered in the interest of administration;

Therefore, in the interest of administration and in view of the above, following transfers and postings of Lecturers are hereby ordered with immediate effect in the schools shown against each,


