Whereas, consequent upon the placement of eligible Masters/Teachers as Lecturers in discipline of English on OPG basis vide Govt order No 235 -Edu of 2019 dated 15/07/2019, 73 newly promoted lecturers were placed and adjusted against available vacancies vide Order No.1213-DSEJ of 2019 dated 02-11-2019

Whereas, it is a settled legal position that transfers and postings at places of choice cannot be claimed as a matter of right and these are essentially made in the interest of administration while taking into consideration individuals preferences in the light of guidelines provided in the existing transfer policy;

Whereas, without prejudice to the above legal position, the said adjustment order provided for review applications in case of any grievance;

Whereas, 27 number of applications were received which have been examined in detail and disposed-off on the basis of individual merit of each case subject to feasibility;


