Sanction is hereby accorded to the temporary appointment of Sh. Sandeep Kumar S/o Sh. Harbans Lal R/o Neota Bharderwah District Doda as Junior Scale Stenographer in the Pay Level SL 6(35400-112400) upgraded Pay Level 6B (35600-112800) and **adjusted in the office of Chief Education Officer, Doda against the vacant post of Junior Scale Stenographer.**

The appointee shall report to the Office of Chief Education Officer, Doda within a period of twenty one days from the date of issuance of this order and shall be allowed to join only on production and verification of the following documents / certificates;

1. Academic Qualification Certificate.
2. Date of Birth Certificate.
3. Domicile Certificate.
4. Health Certificate from the concerned Chief Medical Officer of the District.
5. Loan Certificate under Self Employment Scheme from DIC concerned and Employment Department.
6. All other relevant documents as are required and the instructions as conveyed by the administrative department vide letter quoted under references.

The appointment of the appointee shall further be subject to the following conditions:-

- (a) That she/he shall give an undertaking in the shape of an Affidavit duly attested by the Judicial Magistrate 1st class to the effect that:
 - (I) In case adverse report about his Character and Antecedents is received from the Inspector General of Police, CID/ACB, J&K to whom a reference shall be made that he shall have no right to Claim his appointment as Junior Scale Stenographer in School Education Department and his appointment, as such, shall deemed to have been cancelled ab-initio;



(II) If, on verification, genuineness of the qualification certificates from the concerned issuing authority is found that the same is fake/forged, the claim of the appointee for appointment as Junior Scale Stenographer shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.

- (b) The Salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report in respect of (i) and (ii) above are received in his favour to whom a reference shall be made by the Chief Education Officer Doda.
- (c) The appointee shall be initially on probation for a period of two years.
- (d) The appointment of the candidate is treated as in-service, as the appointee has routed his application form through proper channel.
- (e) If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order he shall forego his right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.

This appointment of the candidate shall be subject to outcome of any writ petition(s) if any, pending in any court of competent jurisdiction of Law.
