- Whereas, Chief Education Officer, Jammu vide letter No. CEOJ/SRO-43/51593-94 dated:-27.12.2019 has submitted a compassionate appointment case of the Mr. Rohit Gorla S/o Late Sh. Gopal Krishan in terms of SRO-43 of 1994.
- Whereas, the applicant has applied for considering his compassionate appointment as class-IV with qualification 10th in lieu of death of his father (died on 17.09.2017); and
- Whereas vide letter No. DSEJ/NG/SRO-43/1054/25399 dated:-12.02.2020, Chief Education Officer Jammu has requested to furnish the clarification on the applying date of the applicant for compassionate appointment in terms of SRO-43/1994; and
- Whereas Chief Education Officer, Jammu vide letter No. CEOJ/Gen/SRO-43/61378 dated:-02.03.2020 has submitted that the applicant has applied for compassionate appointment in terms of SRO-43 of 1994 in the Office of the Headmaster Govt. HS Dogra Hall Jammu on 14.09.2019 with the report that the applicant was underage at the time of death of his father; and
- Whereas vide this office letter No. DSEJ/NG/SRO-43/1054/10874 dated:- 20.05.2020, Chief Education Officer Jammu was requested to furnish the actual date under which the applicant has applied for his compassionate appointment under SRO-43 of 1994; and
- Whereas Chief Education Officer, Jammu vide letter No. CEOJ/Gen/SRO-43/3919 dated:- 27.06.2020 has submitted the requisite information whereunder the applicant has applied for compassionate appointment on 14-09-2019 in terms of SRO-43 of 1994; and
- Whereas, in terms of SRO-43 of 1994 the applicant has to apply within one year from the death of the deceased person (his father). However, in the instant case the applicant has applied after One year eleven months and 14 days.

Now, Keeping in view of above facts and in terms of SRO-43 of 1994 the claim for compassionate appointment in favour of Sh. Rohit Gorla S/o Late Sh. Gopal Krishan, Ex. Class-IV Govt. Girls High School Dogra Hall, District Jammu is hereby rejected.
