Whereas, Chief Education Officer, Kishtwar vide letter No. CEO/K/NT/2020/485-88 Dated 15.05.2020 has submitted a compassionate appointment case of Mr. Raqib Firdous Shapoo S/o Late Sh. Firdous Ahmed in terms of SRO-43 of 1994; and


Whereas, the applicant has applied for considering his compassionate appointment as Lab. Assistant with qualification M.Sc. Zoology in lieu of death of his father (died on 01.03.2018); and

Whereas, Chief Education Officer, Kishtwar has submitted that the case was submitted out of prescribed time period and thereby explanation was sought from Zonal Education Officer Wrawan vide letter No. CEO/K/NT/2020/41092-94 dtd. 12.03.2020 and No. CEO/K/NT/2020/11256-57 dated:-08.05.2020 regarding his lackadaisical approach; and

Whereas, Chief Education Officer Kishtwar has further submitted that ZEO Warwan vide letter No. ZEOW/85-86 dt. 12.05.2020 has intimated that the lackadaisical approach was not on its part, the applicant has submitted his case on 02.02.2020 alongwith allied documents in his office and thereafter the same was submitted in CEO Kishtwar's office for further proceedings; and

Whereas, in terms of SRO-43 of 1994 the applicant has to apply within one year from the death of the deceased person (his father). However, in the instant case the applicant has applied for the compassionate appointment after more than eighteen months.

Now, Keeping in view of above facts and in terms of SRO-43 of 1994 the claim for compassionate appointment in favour of Mr. Raqib Firdous Shapoo S/o Late Sh. Firdous Ahmed Shapoo (Ex. Sr. Assistant), Zonal Education Officer Warwan, District Kishtwar is hereby rejected.
