Whereas, Chief Education Officer, Reasi vide letter No. CEO/Rsi/Esstt/1498 Dated:-24.10.2019 submitted compassionate appointment case of Smt. Maraf Bano W/o Late Bashir Din in terms of SRO-43 of 1994; and

Whereas, the applicant has applied for considering his compassionate appointment under SRO 43 of 1994 as class-IV with qualification 10th in lieu of death of her husband (expired on 01.08.2012); and

Whereas vide letter No. DSEJ/NG/SRO-43/37746 dated:-13.12.2019, Chief Education Officer Reasi was requested to furnish a certificate duly issued by the Deputy Commissioner/Assistant Commissioner (Revenue) of the district to which the deceased employee belonged to the effect that none of the dependents of the deceased is a government employee and element of compassion still existing in the family and also to certify that the widow of the deceased/applicant has not re-married along with Affidavit of one of the dependents namely Mr. Masoom Ellahia (son of the deceased) regarding his no objection in case applicant is appointed under SRO-43/1994; and

Whereas Chief Education Officer, Reasi vide letter No. CEO/Rsi/Esstt/9233-37 dated:-18.03.2020 has submitted a certificate issued by the Assistant Commissioner (Rev) Reas; and

Whereas vide this office letter No. DSEJ/NG/SRO-43/1039/18998 dated:- 10.08.2020, Chief Education Officer Reasi was requested to clarify whether the said case has been rejected earlier or not if yes rejection/pending be informed. Moreover, the applicant has to apply for compassionate appointment interms of SRO-43 of 1994 within one year from the date of death of the deceased; and

Whereas Chief Education Officer, Reasi vide letter No. CEO/Rsi/Esstt/3813-17 dated:- 04.09.2020 has submitted the requisite information whereunder the applicant has applied for compassionate appointment on 06.02.2018 after a gap of five years and six months; and

Whereas, in terms of SRO-43 of 1994 the applicant has to apply within one year from the death of the deceased person (her husband).

Now, Keeping in view of above facts and in terms of SRO-43 of 1994 the claim for compassionate appointment in favour of Smt. Maraf Bano W/o Late Bashir Din (Ex. RRET), HS Bassan, District Reasi is hereby rejected.
