

1. Academic Qualification Certificates.
2. Age and Health Certificate.
3. Permanent Resident Certificate.
4. Dependent Certificate issued by the competent authority.
5. All other relevant documents as are required under SRO-43/1994
6. No Loan Certificate under Self Employment Scheme from DIC Concerned and Employment Department.

This order is, however, subject to outcome of writ petition if any, pending in any competent court of law.

If on verification, the certificates produced by the appointee are proved fake or forged, the appointment shall be cancelled abinitio.

The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report about the verification of his character and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by the Chief Education Officer, Jammu.
