Sanction is hereby accorded to the temporary appointment of Mr. Mohd. Waseem S/o Late Mushtaq Ahmed (Ex. Teacher) Govt. Middle School Barolla (Zone Tikri), R/o Barolla, P.O. Barolla, Tehsil and District Udhampur as Class-IV (Peon) in the Pay Level SL 1 (14800-47100) in the School Education Department in District Udhampur under SRO-43 of 1994.

The appointee shall report to the Chief Education Officer, Udhampur within a period of twenty one days from the date of issuance of this order and shall be allowed to join only on production and verification of the following documents/certificates;

- 1. Academic Qualification Certificate.
- Date of Birth Certificate.
- 3. Domicile Certificate.
- 4. Health Certificate from the concerned Chief Medical Officer of the District.
- 5. Dependent Certificate issued by the Assistant Commissioner Revenue.
- 6. No Loan Certificate under Self Employment Scheme from DIC concerned and Employment Department.
- 7. All other relevant documents as are required under SRO-43/1994.

The appointment of the appointee, shall further be subject to the following conditions:-

- (a) That he/she shall give an undertaking in the shape of an Affidavit duly attested by the Judicial Magistrate 1st class to the effect that:
- (i) In case adverse report about his/her Character and Antecedents is received from the Inspector General of Police, (CID), J&K, to whom a reference shall be made that he/she shall have no right to Claim his/her appointment as Class-IV Department and (Peon) School Education in his/her appointment, as such, shall deemed to have been cancelled ab-initio;
- (ii) If, on verification, genuineness of the qualification certificates from the concerned issuing authority is found that the same is fake/forged, the claim of the appointee for appointment as Class-IV (Peon) shall also be

deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against his/her.

- The Salary of the appointee shall not be drawn and disbursed to (b) him/her unless a satisfactory report in respect of (i) and (ii) above are received in his/her favour to whom a reference shall be made by the Chief Education Officer Udhampur.
- (c) The appointee shall be initially on probation for a period of two years.
- (d) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- (e) If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order he/she shall forego his appointment which shall be deemed to have been cancelled ab-initio without any further notice.

This order is, however, subject to outcome of writ petition if any, pending in any competent Court of Law.
