- 7. All other relevant documents as are required under SRO-43/1994.

The appointment of the appointee, shall further be subject to the following conditions:-

- (a) That he/she shall give an undertaking in the shape of an Affidavit duly attested by the Judicial Magistrate 1st class to the effect that:
- (i) In case adverse report about his/her Character and Antecedents is received from the Inspector General of Police, (CID), J&K, to whom a reference shall be made that he/she shall have no right to Claim his/her (Lab. Bearer) appointment as Class-IV in School Education his/her appointment, as such, shall deemed to have Department and been cancelled ab-initio;
- (ii) If, on verification, genuineness of the qualification certificates from the concerned issuing authority is found that the same is fake/forged,

the claim of the appointee for appointment as Class-IV (Lab. Bearer) shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against his/her.

- (b) The Salary of the appointee shall not be drawn and disbursed to him/her unless a satisfactory report in respect of (i) and (ii) above are received in his/her favour to whom a reference shall be made by the Chief Education Officer Doda.
- (c) The appointee shall be initially on probation for a period of two years.
- (d) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- (e) If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order he/she shall forego his appointment which shall be deemed to have been cancelled ab-initio without any further notice.
