
Sir,

National Council of Educational Research and Training (NCERT) has been offering the Diploma Course in Guidance and Counselling for training in-service teachers to become professional counsellors for schools and allied institutions since five decades or so. In view of the urgency to make the counselling services available in schools and to train professionals in large numbers in the context of universalisation of secondary education as well as adolescence education and mental health, NCERT offers the course for teachers, teacher educators, school administrators and untrained guidance personnel from the Directorates of Education Departments with a combination of distance and face-to-face modes.

The one year course begins from the first week of January every year and is consisting of three phases viz. Guided Self Learning ( 6 months) ; Intensive Practicum ( Face to Face) ( 3 months); Internship ( 3 months).

You are requested to kindly nominate school teachers from your respective district who are likely to use the training to carry forward in this area in schools.
