**Sub:- Compliance of Transfer order(s).**

**NOTICE**

In the interest of Administration and in the larger interest of student community transfer orders of **Lecturers/Headmasters/Masters** were issued from this office to utilize the Human Resource properly but it has been reported from all the Districts that instead of complying with the order(s) a large number of official preferred representations for modification of transfer orders on various grounds and has not joined their new place(s) of posting. As such, after scrutiny of the representations, the cases found genuine on humanitarian/ domestic/health grounds were considered and necessary modifications were made on the basis of merit and instructions were issued vide this office order No. **264-DSEJ of 2016 dated 26-05-2016** that no mid-session transfers be henceforth processed, except in case of extreme medical grounds.


It is worth mentioning that, in terms of Rule 27 of Classification Control and Appeal Rules, 1956, a member of a service or class of a service may be required to serve in any part of the Jammu and Kashmir State in any post borne on the cadre of such service or class and an employee holding transferable post has no right to insist that he/ she should be allowed to serve at a particular period since transfer is generally a condition of service and transfer from one place to another is necessary in public interest and efficiency in the public administration.

Also vide Govt. Order No. **327-Edu of 2015 dated 10-07-2015**, after due deliberations the cases based on the merit were considered and modified. All others who have represented in pursuance to above quoted orders and whose orders of modification have not been issued being devoid of merit under the transfer policy of the department issued by Govt. Order No **622-Edu of 2015 dated 22-12-2015** are being informed through notice that their cases have

view of report furnished by the CEOs this is the last and final opportunity being afforded to them as a warning for compliance of order before disciplinary action is taken, under rules.

Needless to mention here that due to non-joining of officials/officers on the pretext of medical grounds/court directions or otherwise it has become difficult for the administration to utilize the human resource in a positive and constructive manner and least to mention about the loss being inflicted upon the innocent student's future.

Therefore, in order to improve the Administration as also to ensure proper staffing in the schools, through the medium of this notice, a last opportunity is hereby granted to transferees who have not yet joined their new place(s) of posting, to join their new place of posting within two days from the date of publication of this notice failing which action warranted under rules shall be initiated against them.
