Sub: Conducting of raid at the residence of Sh. Ankush Gupta, Teacher by Principal HSS Ramnagar indulging in Private tuition at his home in contravention of Government orders and action taken thereof.

ORDER

Whereas, an order No.572-DSEJ of 2015 dated 26.10.2015 was issued whereby practising tuitions at home or at coaching centres by Government Teachers was prohibited; and

Whereas, as per the order, it was made amply clear that private tuitions by Government Teachers, being a moral turpitude, is a serious violation of service conduct rules. Therefore, CEOs was authorised to constitute committees of senior officers with impeccable integrity at District and Zonal level to monitor and ensure that Government Teachers (which includes Masters and Lecturers as well) do not indulge in this practice and need to conduct surprise raids on such private tuition centres and coaching centres; and

Whereas, a complaint was received against one Shri Ankush Gupta, Teacher (Probationer) HSS Ramnagar that he is indulged in private tuition in his home town Ramnagar and thereby charging hefty amount for such activities from various students; and


Whereas, as reported by the CEO Udhampur that earlier also Sh. Ankush Gupta, Teacher (Probationer) had been given a warning by the CEO Udhampur indulged in Private Tuitions thereupon the delinquent teacher had given an affidavit that he had not been giving any tuition before or after Schools hours privately and not involved in such type of practice and if found in such practice, he shall be personally responsible and action taken by the department shall be acceptable to him; and

Whereas, on receiving repeated complaints and on the instructions of the undersigned, CEO Udhampur conducted raid in his private tuition centre by a team headed by Principal HSS Ramnagar, who, vide his report No.HSS/Rgr/116-120 dated 31.05.2016 submitted that the teacher was found indulging in private tuition and caught red handed

giving tuition to 11th Class students of Chemistry. The Principal HSS Ramnagar could interact with 5 students of the tuition group who confirmed his involvement in tuition work which clearly shows his involvement and violation of the Government order; and

Whereas, vide letter No.CEOU/E-2/6519-24 dated 31/05/2016, CEO Udhampur warned the delinquent teacher of suspension for violation of the Government order giving him a warning and opportunity to show cause in his conduct by 12:00 noon of 1.6.2016.

As the said teacher has violated the services conduct rules and also liable for punishment u/s 199 of RPC for having sworn false on affidavit, the delinquent Teacher Sh.Ankush Gupta, posted at Govt. High School Rang, Tehsil Ramnagar, District Udhampur **is hereby placed under suspension with immediate effect.** Further, **no salary for the month of May 2016 and annual increment shall be released in favour of the delinquent teacher till settlement of the case.** Being a Probationer, his services shall not be confirmed till improvement in his conduct that has to be duly confirmed by the head of the institution in which he has been posted.
