**Subject:- Confirmation of results for the session 2016-17 Winter-Summer Zone.**

1. Whereas, various representations have been received from the association of Private Schools regarding the difficulties faced by them in getting results of their students confirmed/countersigned from the ZEO's and CEO's after the conclusion of academic session; and
2. Whereas, it has been observed that the said practice of confirmation of results has been continuing due to following reasons.
  - (a) To prevent exploitation of students by unrecognised Schools.
  - (b) To facilitate smooth transfer of students from one recognised school to another.
  - (c) To prevent commercialization of education by some Schools.
3. Whereas, it has been reported that the said exercise of countersigning of results from ZEO's/CEO's has become quite problematic for the Private schools due to several conditions imposed by the CEO's/ZEO's (varying from District to District) on the Private Schools.
4. It is, therefore clarified, in order to have uniform procedures in the entire Jammu Division, that the CEO's/Dy.CEO's/ZEO's shall be required to countersign the results, strictly based on the following parameters:
  - (a) The ZEO' shall be entitled to countersign for Private Middle Schools in their respective jurisdictions.
  - (b) The CEO's/Dy.CEO's (where applicable) shall be entitled to countersign for Private High/Higher Secondary Schools in their respective jurisdictions.
  - (c) The Private Schools shall be required to produce the countersigned result of the previous academic year alongwith the proof of recognition of the School.



- (d) The current result will be countersigned if the students figuring therein are exactly similar (as per complete particulars) to the previous academic year.
- (e) Authenticated/Countersigned the School Leaving Transfer Certificate of the previous School shall be required only in case a student is figuring in the current result but he/she did not figure in the countersigned result of the previous year.
- (f) Authenticated Birth Certificates/Proof may be asked in case of the result of standard 1.
- (g) The results of only those classes shall be confirmed/countersigned for which the School is recognized/permited by the competent authority or for which classes it last stood recognized/permited but its current recognition/permission is under process.
