Sub:- Regularization of Rehbar-e-Taleem Teachers working in KGBV.

Ref:- (i) Govt. Order No. 242-Edu of 2016 dated 30-6-2016.

Order No. 567-DSEJ of 2016


Dated: 25-10-2016

In pursuance to the Govt. orders referred supra, sanction is hereby accorded to the regularization of (19) Rehbar-e-Taleem working in KGBV (as per details given in **Annexure "A"**) in the pay scale of 5200-20200 with grade pay Rs. 2800/- for graduate and 5200-20200 with grade pay 2400/- for undergraduates, (as the case may be) subject to the fulfillment of following conditions:-

- i) That the Rehbar-e-Taleem(s) has/have completed five years continuous / un-interrupted service and was/were engaged genuinely.
- ii) That the work and conduct of the Rehbar-e-Taleem(s) teacher has/have remained satisfactory for the last five years which shall be certified by the Village Education Committee concerned in association with respective ZEO/Head of institution/CEO as the case may be.
- iii) That the Rehbar-e-Taleem(s) posses the minimum prescribed qualification for engagement at the time of initial appointment as Rehbar-e-Taleem through JK Board of School Education/University or any other recognized Board/University and has not obtained any qualification/degree(s) through study centre/distance mode.
- iv) That none of RET(s) has/have remained on the rolls of any college/institution during the five years of honorarium service.
- v) That the CEO/DDO concerned shall ensure that the maternity leave, if any, availed by the female ReTs during 5 years honorarium service, which has not been reported/reflected earlier, is entered in the service book of such ReT(s) whose regularization has been considered.
- vi) That the CEO/DDO concerned shall remain personally responsible to verify following original testimonials and ensure that the ReTs fulfils all the

conditions as laid down in the above cited Government Orders before giving effect to their regularization:-

- a) Educational-qualification certificates.
 - b) Age and Health certificate.
 - c) Permanent Residence Certificate.
 - d) No Loan certificate from District Industries Centre/Self Employment Scheme.
 - e) Character/Antecedents verification certificates from IGP, CID.
 - f) Category certificate in case of ST/SC/ALC/RBA candidates, if appointed under reserved category.
- vii) That in case, at any stage, it is found that the certificates/documents furnished by the appointees are fake/fictitious the order of appointment/regularization shall be cancelled *ab initio*.
- viii) As a matter of policy and consistent with the imperatives of smooth working of respective schools, the Rehbar-e-Taleem so regularized shall not be transferred.
- ix) That none of the qualification antecedents of rets shall be obtained from Moullan-e- Urdu from Jamia Urdu Aligrah B.Ed Degree acquired from other universities namely PRIST university Tamil Nadu MDV Rohtak University Maghad University Kota Raja University, Rajasthan, Rukelkjand University, Gulburga University, HSS Paryog University Gurukul Mathra University and BSP University (UP) or any other fake university. The proper verification of this aspect shall be the personal responsibility of Zonal Education Officer concerned.
- x) This order is issued without prejudice to the outcome of any writ petition/suit/case, pending adjudication in the court of law.


