Sub: - **Adjustment of Masters promoted vide order No: DSEJ/NG/M/Prom/7255-68 dated 11-02-2014 (Drop-out cases).**

ORDER NO: 141 DSEJ OF 2017.

1. Whereas, the Departmental Promotion Committee meeting was held on 08-02-2014 under the chairmanship of the then Director School Education, Jammu;
2. Whereas, DPC examined the promotion cases of trained graduate/ Post graduate teachers and cleared promotion of 1000 teachers as masters and 195 as dropout cases;
3. Whereas, the promotion orders of trained graduate/ Post graduate teachers (male/female) as masters in the grade of Rs. 9300-34800 (Revised)+ grade pay Rs. 4280 was issued vide order No. DSEJ/NG/M/Prom/7255-68 dated 11-02-2014;
4. Whereas, complaints regarding the irregularities in the DPC was forwarded by Administrative Department vide their letter No: Edu/Vig/57/2015 dated 18-12-2015;
5. Whereas, a committee was constituted vide order No. 510 DSEJ of 2015 dated 04-09-2015 for verification of Degrees and qualification certificates of teachers promoted as Masters vide Order No. DSEJ/NG/M/Prom/7255-68 dated 11-2-2014 and detailed report in the matter was submitted to Administrative Department vide letter No. DSEJ/NG/M/59034 dated 20-01-2016;
6. Whereas, an FIR No. 30/2015 u/s 5(1)(d) J&K PC Act read with section 5(2) P.C. Act Svt. 2006 and section 420, 467,468,120-B RPC P/s Vigilance Organization, Jammu was lodged by State Vigilance Organization;


7. Whereas, the matter was examined in the Administrative Department and vide letter No: Edu/Vig/57/2015 dated: 04-08-2016, it was conveyed that appointing authority is empowered to rescind all such promotion orders which have been effected without following the due process of the law which inter alia includes fulfillment of the eligibility conditions;
8. Whereas, vide letter No: DSEJ/NG/31035 dated: 30-08-2016, the Administrative Department was apprised of the court directions in the SWP No. 277/2015 pending adjudication before Hon'ble High Court, regarding original records pertaining to DPC having been called by the Vigilance Organization and the same having been handed over to VO Jammu;
9. Whereas, the Administrative Department vide letter No: Edu-Vig/57/2015 dated: 11-09-2016 directed to take action on the directions issued in the letter dated: 04-08-2016 in the matter with due diligence;
10. Whereas, a meeting was held in the Administrative Department on 10-11-2016, wherein it was decided that an updated seniority list of Trained Graduate/Post Graduate teachers as on 01-01-2014 is required to be put on the public domain for inviting objections;
11. Whereas, a committee of eleven members was constituted vide order No. 584-DSEJ of 2016 dated 15-11-2016 for re-verification of Degrees and Qualification certificates of teachers promoted as Masters vide order No. DSEJ/NG/Prom/7255-68 dated 11-02-2014;
12. Whereas, notification of updated seniority of trained graduate / post graduate teachers was issued vide letter No. DSEJ/NG/M/49845-58 dated 22-11-2016 and uploaded on the official website of the Directorate of School Education, Jammu for inviting objections. The notification was published in two dailies on 24-11-2016;
13. Whereas, the verification committee submitted its report on 28-12-2016;
14. Now, adjustment /postings in respect of 20 (Drop-out) promotees annexed as Annexure-A' to this order who have acquired degrees through regular mode is issued;



However, adjustment orders in respect of 21 (Twenty One) Drop-out promotees who have acquired degrees through Distance/Correspondence/Private shall be issued separately after the relevant test is conducted by the J & K Board of School Education, Jammu for Graduation/B.Ed degrees in pursuance to G.O. No 66-Edu of 2017 dated 16-02-2017.

The promotees adjusted in the different institutions shall report to Head of the Institution within 21 days from the issuance of this order, failing which it will be presumed that the promotee is not interested to avail the benefit of promotion and his/her promotion will automatically deemed to be cancelled without any further notice to the concerned. The concerned CEO will e-mail the list of promotees (Masters) who fail to join within stipulated period on the next day of cut of date of joining. Further instructions conveyed vide Govt. Order No. 337-Edu of 2015 dated: 10-07-2015 shall be strictly adhered.

This order is issued without any prejudice to the outcome of writ petition/(s), if any, pending before Hon'ble Court of Law.
