In terms of the J&K Compassionate Appointment Rules, 1994, notified vide SRO-43 dated 22-02-1994, as amended from time to time and approval conveyed by the Administrative Department sanction is hereby accorded to the temporary appointment Mr. Waseem Iqbal S/O Late Mtr. Zabeda Begum Ex- Teacher Govt. BPS Margan Zone Darhal R/O Ujhan District Rajouri under SRO-43 of 1994 as Class-IV (peon) in the Pay Scale of 4440-7440 with grade pay of Rs. 1300/- in the School-Education Department in District Cadre Rajouri under SRO-43 of 1994.


The appointee shall report to the Chief Education Officer, Rajouri within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production and verification of the following documents/certificates:

1. Academic Qualification Certificates.
2. Age and Health Certificate.
3. Permanent Resident Certificate.
4. Dependent Certificate issued by the competent authority.
5. All other relevant documents as are required under SRO-43/1994
6. No Loan Certificate under Self Employment Scheme from DIC Concerned and Employment Department.

This order is, however, subject to outcome of writ petition if any, pending in any competent court of law.

If on verification, the certificates produced by the appointee are proved fake or forged, the appointment shall be cancelled abinitio.

The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report about the verification of his character and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by the Chief Education Officer, Rajouri.
