Sub: - **Cancellation of Promotion orders of Masters promoted vide order No: DSEJ/NG/M/Prom/7255-68 dated 11-02-2014 being already promoted in the previous DPCs.**

ORDER NO: 191- DSEJ OF 2017.
DATED: 08-03-2017


1. Whereas, the Departmental Promotion Committee meeting was held on 08-02-2014 under the chairmanship of the then Director School Education, Jammu;
2. Whereas, DPC examined the promotion cases of trained graduate/ Post graduate teachers and cleared promotion of 1000 teachers as masters and 195 as dropout cases;
3. Whereas, the promotion orders of trained graduate/ Post graduate teachers (male/female) as masters in the grade of Rs. 9300-34800 (Revised)+ grade pay Rs. 4280 was issued vide order No. DSEJ/NG/M/Prom/7255-68 dated 11-02-2014;
4. Whereas, complaints regarding the irregularities in the DPC was forwarded by Administrative Department vide their letter No: Edu/Vig/57/2015 dated 18-12-2015;
5. Whereas, a committee was constituted vide order No. 510 DSEJ of 2015 dated 04-09-2015 for verification of Degrees and qualification certificates of teachers promoted as Masters vide Order No. DSEJ/NG/M/Prom/7255-68 dated 11-2-2014 and detailed report in the matter was submitted to Administrative Department vide letter No. DSEJ/NG/M/59034 dated 20-01-2016;
6. Whereas, an FIR No. 30/2015 u/s 5(1)(d) J&K PC Act read with section 5(2) P.C. Act Svt. 2006 and section 420, 467, 468, 120-B RPC P/s Vigilance Organization, Jammu was lodged by State Vigilance Organization;

7. Whereas, the matter was examined in the Administrative Department and vide letter No: Edu/Vig/57/2015 dated: 04-08-2016, it was conveyed that appointing authority is empowered to rescind all such promotion orders which have been effected without following the due process of the law which inter alia includes fulfillment of the eligibility conditions;
8. Whereas, vide letter No: DSEJ/NG/31035 dated: 30-08-2016, the Administrative Department was apprised of the court directions in the SWP No. 277/2015 pending adjudication before Hon'ble High Court, regarding original records pertaining to DPC having been called by the Vigilance Organization and the same having been handed over to VO Jammu;
9. Whereas, the Administrative Department vide letter No: Edu-Vig/57/2015 dated: 11-09-2016 directed to take action on the directions issued in the letter dated: 04-08-2016 in the matter with due diligence;
10. Whereas, a meeting was held in the Administrative Department on 10-11-2016, wherein it was decided that an updated seniority list of Trained Graduate/Post Graduate teachers as on 01-01-2014 is required to be put on the public domain for inviting objections;
11. Whereas, a committee of eleven members was constituted vide order No. 584-DSEJ of 2016 dated 15-11-2016 for re-verification of Degrees and Qualification certificates of teachers promoted as Masters vide order No. DSEJ/NG/Prom/7255-68 dated 11-02-2014.;
12. Whereas, the verification committee in its report submitted on 28-12-2016 reported that :-
- a) 07 (Seven) teachers of District Poonch, Rajouri, Kishtwar and Kathua stand already promoted in DPC-2013.
 - b) 08 (Eight) teachers of Jammu, Doda, Poonch and Udhampur of various categories were not eligible for promotion due to the submission of wrong date of 1st appointment as teachers from subordinate offices.
 - c) 06 (six) teachers stands already promoted as I/C Lecturers in various disciplines.

Now, accordingly it is hereby ordered that promotion orders issued vide Order No: DSEJ/NG/M/Prom/7255-68 dated 11-02-2014 in respect of:-

- i) 07 (seven) teachers already promoted as master in DPC-2013 annexed "A" is hereby rescinded ab-initio.
- ii) 08 (Eight) teachers who were not eligible for promotion due to submission of wrong date of 1st appointment by subordinate offices annexed "B" is hereby rescinded ab-initio.
- iii) 06 (six) teachers who already stands promoted as I/C Lecturers in various disciplines annexed "C" is hereby rescinded ab-initio.
