***Sub: Drawal of pay of the surplus, Academic requirement, Court cases, Medical grounds (life consuming) and Rationalization- regarding Masters.***

**ORDER**

Whereas, many representations have been received in this Directorate about non-drawal of salary of masters in Jammu Division;

Whereas, 589 of masters have already been allotted posts vide order No's. DSEJ/NG/M/52575-688 dated 08-11-2018, DSEJ/NG/M/53332-54576 dated 16-11-2018, DSEJ/NG/M/55648-56148dated 29-11-2018& DSEJ/NG/M/56489-57509 dated 01-12-2018;

Whereas, the names of many masters could not be inadvertently included in the above mentioned orders;

Whereas among these Masters many masters with disability condition and many on the verge of retirement have also not been able to draw their salary for the last few months;

Whereas, this situation has arisen mainly because many masters are working as surplus in respective Districts;

Whereas, it imperative to adjust these masters against substantive posts;

Whereas, such rationalization exercise is being undertaken after considering merit of each case;

Whereas, in the mean time, salary needs to be disbursed to them which has been pending for the last few months and is causing serious financial crisis for such masters;

Whereas, the Adm. Department has accorded sanction to the Formal Merger of 526 posts of Headmasters and 3132 posts of Subject Specific Masters created under RMSA with Headmasters and Masters in the School Education Department vide **Govt. Order No. 19-Edu of 2019 dated 22-01-2019**;

Therefore, in view of the above and in the light of Finance Department Circular No. 104-F of 2018 dated 27-03-2018, a list of such left out surplus masters is being issued indicating the posts now allotted strictly for the purpose of drawing salary upto Feb. 2019 or till they are placed against substantive posts whichever is earlier. Moreover, the Masters working on the posts of RMSA shall draw their salary on their substantive posts in view of Govt. Order No. 19 Edu of 2019 dated 22-01-2019.
