
ORDER

As approved by the Administrative Department, post facto sanction is accorded to the grant of Time Bound Promotion (in Situ) to Higher Standard pay scales scheme in terms of SRO-14 of 1996 dated 15-01-1996, SRO-225 dated 04-07-1997 & SRO-42 dated 02-02-2011 in favour of Late Kishore Dev Singh, Master, Govt, City HS (Boys) Udhampur, subject to the fulfillment of the condition recorded from S.No. 01 to 07 below:-

1. That no Higher standard pay-scale shall be granted to the employee who is under suspension on the date of eligibility or who is charge-sheeted under provision of J&K classification control and appeal rules or any other rules for the purposes;
2. That such period of leave without allowances as had not been agreed to by the competent authority to be counted for purpose of annual increment shall not be taken into account for reckoning of the period of 9/18/27 years for Higher standard pay-scale as the case may be;
3. That the benefit of promotion shall not be given to such employee, who relinquishes promotion for reasons what so ever;
4. That the work and conduct of the concerned eligible employees has remained satisfactory as per A'PR's together with result for preceding three years;
5. That the requisite proforma has been obtained alongwith undertaking in schedule 1 and 2 from the concerned eligible employees;
6. That the officials whose lien/promotion prospectus have been retained in Kashmir Division, their promotion In situ under SRO-14 of 1996 dated 15-01-1996/SRO-225 of 1997 dated 04-07-1997 has not to be considered and
7. That if there is any case against of the official included in the sanction order pending in the department/Vigilance Deptt./Court of Law, the Situ promotion granted in such case should not be implemented and his/her case be referred to this Directorate for cancellation of his/her Situ promotion immediately.

Since it is a death case the monetary benefits should be released immediately and the case processed under rules.
