Sanction is hereby accorded to the temporary appointment of Danish Farooq S/o Late Farooq Ahmed (Ex-RRET) UPS Khanpura Dugroon, R/o Bathri, P.O. Malanoo, Tehsil Kahara and District Doda as (MTS) **Multitasking staff** lying vacant at Govt. Higher Secondary School Malanoo in the Pay Level SL 1 (14800-47100) in the School Education Department in District Doda under SRO-43 of 1994 after receipt of satisfactory verification report from Spl. Director General CID vide letter quoted under reference and in pursuance to Govt. Order No. 528-JK(GAD) of 2021 dt. 21.06.2021.

The appointee shall report to the Chief Education Officer, Doda within a period of twenty one days from the date of issuance of this order and shall be allowed to join only on production and verification of the following documents/certificates;

1. Academic Qualification Certificate.
2. Date of Birth Certificate.
3. Domicile Certificate.
4. Health Certificate from the concerned Chief Medical Officer of the District.
5. Dependent Certificate issued by the Assistant Commissioner Revenue.
6. All other relevant documents as are required under SRO-43/1994.

The appointment shall further be subject to the following conditions:-

- a) That if the candidate has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District industries Centre (DIC) and District Employment and Counselling Centre of the domicile district, he shall relinquish the proprietorship of unit/enterprises and also stakes, if any, in such self-employment unit/enterprise before joining the Government service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.
