ORDER NO: 09 DSEJ of 2025

Whereas, the applicant no. 1 namely Savita Manhas was engaged as Rehbar-E-Taleem (ReT) in Govt Primary School, Khati, Zone Bhagwah, District Doda and after completing five years of regular service as ReT teacher regularized as General Line Teacher, thereafter, teacher Grade-II; and

Whereas, the applicant no. 2 namely Mohd Sharief was engaged as 3<sup>rd</sup> Teacher in Govt Girls Upper Primary School, Kashtigarh, District Doda and after completing five years of regular service regularized as General Line Teacher; and

Whereas, the Department has issued a notification vide No. 02-JK(Edu) of 2023 dated 15.06.2023, thereby inviting applications for mutual transfers of RReT teachers in terms of G.O. No. 20-Edu of 2019 dated 22.01.2019; and

Whereas, the applicant namely Savita Manhas and Mohd Sharief also applied for mutual transfer but their mutual transfer was not effected at that point in time; and

Whereas, thereafter, the applicants have filed Original application bearing **O.A. No.305/2024 titled Savita Manhas & and V/s UT of J&K and others** before the Hon'ble Central Administrative Tribunal, Jammu and has sought following relief in the matter:-

**"Direct the respondents to issue the orders transferring the applicants from Govt. Primary School Khati and vice Mohd. Sharief (RRET) from Govt. Girls Upper Primary School Kashtigarh and Vice-Versa in Zone Bhagwah District Doda on Mutual Transfer Basis as already done for the similarly situated employees of the respondent department."**

Whereas, the Hon'ble Central Administrative Tribunal vide order dated 16.03.2024 has disposed of the Original Application with the following directions:-

**"....."Considering the above submissions of counsel for the parties, this O.A. is disposed of at the admission stage, without entering into the merits of the case, directing the respondent No. 1 and 2 to consider transferring the applicant from Govt Primary School, Khati vice Mohd Sharief from Govt Girls Upper Primary School, Kashtigarh and vice versa in zone Bhagwah District Doda on mutual transfer basis as already done for the similarly situated employees as per provisions of relevant applicable rules and binding instructions on the subject and decide it with a reasoned order within a period of six weeks from the date of receipt of a certified copy of this order and the order so passed shall also be communicated to the applicants. No costs."**

Whereas, in compliance with the aforementioned direction of the Hon'ble CAT, the case of the applicants was examined in light of the Government Order No. 20-Edu of 2019 dated 22.01.2019, State Administrative Council decision No. 166/22/2018 dated 07.12.2018) and G.O. No. 192-JK (Edu) of 2023 dated 27.06.2023. Further, Point 3(a) of Order No. 20-Edu of 2019 dated 22.01.2019 reads as under:-

**“.....The service conditions of the Teachers Grade-II shall be the same as prescribed for the General Line Teachers with the exception that they shall not be transferable except on the mutual basis to the post of other teacher Grade-II/RREts/ReTs in exceptional circumstances.....”**

Now, therefore, keeping in view of the facts and circumstances of the case as well as the order dated 16.03.2024 passed by the Hon'ble Central Administrative Tribunal, Jammu in case **O.A. No.305/2024 titled Savita Manhas & and V/s UT of J&K and others**, sanction is hereby accorded to the mutual transfer of the following RREts (Teacher Grade-II/ReT 3<sup>rd</sup> teacher) on reciprocal basis.

The above said mutual order is subject to the following conditions:-

1. The teachers (Grade-II/ReT 3<sup>rd</sup> teacher) so transferred are working at their actual place of engagements/appointments.
2. They have not been promoted/appointed/selected on higher post as on date.
3. Having minimum one year of service in their cadre.
4. No joining time and TA/DA is allowed.
