Sub: Uploading of authenticated data on Aadharshila Portal & Enrolment Drive -2024. CIRCULAR

The Aadharshila Portal has been developed to capture all essential data regarding students, teachers, infrastructure, Video, Photos and all other relevant data so as to ensure credible and authentic data for use in planning, monitoring and managing the Schools efficiently. Therefore, it is imperative that credible data is updated continuously and with due care so that there is no discrepancy in the data.

However, it has been observed that many Hols, ZEOs etc have not taken due care in uploading data, time to time, resulting in either filling of wrong data or delay in updating the current data. In this regard, all the CEOs shall henceforth observe the following procedures: -

- The CEOs shall facilitate all the respective DNOs/ZNOs wherever required so that the data is continuously filled and updated on the portal and update the undersigned about New Admission under the "Enrolment Drive-2024" w.e.f. 15-05-2024 to onward as per the format.
- All the students whose data is uploaded on the Aadharshila Portal shall be given unique ID No. on the Portal. The Unique ID No of the student and PEN (Permanent Education Number given by Udise Plus) should not be changed during the entire schooling period even if the student shifts from Government to Private School and vice versa.
- All ZEOs and other authenticating officers shall not confirm the result of the students if the Unique ID of the Aadharshila and PEN are not mentioned against the name of the student in the
- Head of Complexes and Hols shall certify the genuineness and veracity of data uploaded on result sheet. the portal of their respective Schools. Thereafter ZNOs/ZEOs/ and DNOs/CEOs shall certify the genuineness of the data.
- The Complex Heads of 378 complexes, ZEOs, and all other Hols shall ensure timely updation of the data and entrust the responsibility of updating data to an efficient teacher of the institution.

All the above instructions shall be complied in letter and spirit and in case of any clarification, the Nodal Officer Aadharshila in the Directorate, Dr. Jagdish Raj Panotra, M.No.9419194492, may be contacted. Moreover, the compiled information at CEO level of New admission under Enrolment Drive-2024 should be shared on aforesaid what's app mobile number as per the attached format in a annexure "A". on the daily basis by or before 2 PM.
