

Whereas, in the tentative seniority list the name of Smt. Nishi Sharma, Master HSS Purmandal stands at S.No 38; and,

Whereas, after receiving representations from the stake holders the name of Smt. Nishi Sharma was placed at S.NO 43 in the updated seniority list of masters promoted upto 25-05-2005 maintained in the Directorate and also available on the official website as well as in the office of Chief Education Officers of Jammu Division vide No. DSEJ/Gaz/24832-24850 dated 27-07-2019; and,
