Sub: Review of suspension case of Sh. Naseer Ahmed, Master, MS Naka Lowarka Sangiote, Zone Balakote, District Poonch and decision thereof.

ORDER

Whereas, vide Government Order No. 223-Edu of 2017 dated 16-05-2017, a Review Committee was constituted to review the suspension of non-gazetted employees of School Education Deptt.; and

Whereas, Sh. Naseer Ahmed, Master was placed under suspension by CEO Poonch vide order No. CEO/Estt/14977-78 dated 09-10-2015 in a case FIR No. 100/2015 u/s 420, 405, 406, 467, 468 RPC in Police Station, Surankote. The CEO Poonch vide No. CEO/P/legal/19096 dated 12-02-2021 has made the following specific recommendations:-

"As the official has been acquitted by the Trial Court, Principal Sessions Judge, Poonch order dated 28-11-2020, as such the case is hereby recommended for reinstatement".

Whereas, it is pertinent to mention here that the Hon'ble Court of Principal Sessions judge, Poonch vide judgement dated 18-11-2020 while acquitting the accused had dismissed the case titled state V/s Naseer Ahmed. As such the case placed before the Review Committee on 18-02-2021 and the committee considered the case and decided to reinstate the official subject to the condition that no appeal has been filed against the order dated 28-11-2020 of the Principal Sessions Judge, Poonch; and

Whereas, vide this office order No. DSEJ/legal/9625-26 dated 15-03-2021, Sh. Naseer Ahmed, Master was reinstated subject to the condition that no appeal has been filed against the order dated 28-11-2020 of the Principal Sessions Judge, Poonch and it was mentioned in the order that his period of suspension will be decided lateron; and

Whereas, CEO Poonch vide letter No. CEOP/legal/12579-80 dated 30-07-2021 has stated that learned Public Prosecutor of District Court Poonch vide his No. 209/PP dated 01-07-2021 has stated that no appeal has been preferred in the instant case. Further, as reported by ZEO Balakote vide his letter dated 19-07-2021 it has been stated that the said official has continuously performed his duties in HSS Bhatadhurian from the date of suspension to the date of reinstatement and has requested for the settlement of his suspension period; and

Whereas, the case of the Master was placed before the Review Committee which met in the Directorate on 20-01-2022 under the chairmanship of Director School Education, Jammu and after threadbare discussions/ deliberations in the instant case, the Committee made the following recommendations:-

"The Committee decided to treat the suspension period as on duty subject to the condition that he has marked his attendance during the said period of suspension. Further the official will furnish an undertaking that he has not worked anywhere else during that period".

Now, therefore in view of the recommendations of the Review Committee, the suspension period of the official namely Sh. Naseer Ahmed, Master is treated as on duty subject to the condition that he has marked his attendance during the said period of suspension. Further the official shall furnish an undertaking that he has not worked anywhere else during that period. The CEO Poonch will take further appropriate action in the matter under an intimation to this office.
