- That the employees availing the benefit shall give an undertaking to the effect that as and when he/she becomes due for functional promotion 1. he/she will not refuse:
- That no Higher standard pay-scale shall be granted to the employee who is under suspension on the date of eligibility or who is charge-sheeted 2. under provision of J&K classification control and appeal rules or any other rules for the purposes; 3.
- That such period of leave without allowances as had not been agreed to by the competent authority to be counted for purpose of annual increment shall not be taken into account for reckoning of the period of 9/18/27 years for Higher standard pay-scale as the case may be;
- That the benefit of promotion shall not be given to such employee, who relinquishes promotion for reasons what so ever;
- 5. That the work and conduct of the concerned eligible employees has remained satisfactory as per A'PR's together with result for preceding three 6.
- That the requisite proforma has been obtained alongwith undertaking in schedule 1 and 2 from the concerned eligible employees;
- That the officials whose lien/promotion prospectus have been retained in Kashmir Division, their promotion In situ under SRO-14 of 1996 dated 7. 15-01-1996/SRO-225 of 1997 dated 04-07-1997 has not to be considered and
- 8. That if there is any case against of the official included in the sanction order pending in the department/Vigilance Deptt./Court of Law, the Situ promotion granted in such case should not be implemented and his/her case be referred to this Directorate for cancellation of his/her Situ promotion immediately. 9.
- In respect of Masters now Incharge Lecturer a note is to be recorded in their service books that the time bond promotion shall be withdrawn in case he/she is promoted/regularized prior to in-situ promotion and recovery shall be made.
