She shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned of the appointee





- regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.
- b) That she will give an undertaking in the shape of an Affidavit duly attested by the Executive Magistrate, 1st Class to the effect that if on verification, genuineness of the qualification certificates from the concerned issuing authority is found fake/forged, the claim of the appointee for appointment as MTS shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against the applicant.
- c) The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report in respect of (a) & (b) above are received in her favour.
- d) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- e) If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order she shall forego her right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
