Sanction is hereby accorded to the temporary appointment of Lakshi Sharma D/o Late Smt. Sunita Sharma (Ex-Laboratory Assistant) Govt. Hr. Sec. School Dhangri District Rajouri, R/o Village Peo Manyallan P.O. Gunni Tehsil and District Rajouri as (MTS) **Multitasking staff** lying vacant at **Govt. High School Sagote** in the Pay Level SL 1 (14800-47100) in the School Education Department in District Rajouri under SRO-43 of 1994 after receipt of satisfactory verification report from Special Director General CID vide letter under reference and in pursuance to Govt. Order No. 528-JK(GAD) of 2021 dt. 21.06.2021.

The appointee shall report to the Chief Education Officer, Rajouri within a period of twenty one days from the date of issuance of this order and shall be allowed to join only on production and verification of the following documents/certificate:

1. Academic Qualification Certificate.
2. Date of Birth Certificate.
3. Domicile Certificate.
4. Current Marital Status.
5. Health Certificate from the concerned Chief Medical Officer of the District.
6. Dependent Certificate issued by the Assistant Commissioner Revenue.
7. All other relevant documents as are required under SRO-43/1994.


The appointment shall further be subject to the following conditions:-

- a) That if the candidate has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment and Counselling Centre of the domicile district, she shall relinquish the proprietorship of unit/enterprises and also stakes, if any, in such self-employment unit/enterprise before joining the Government service. She shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned of the appointee

regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.

- b) That she will give an undertaking in the shape of an Affidavit duly attested by the Executive Magistrate, 1<sup>st</sup> Class to the effect that if on verification, genuineness of the qualification certificates from the concerned issuing authority is found fake/forged, the claim of the appointee for appointment as MTS shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against the applicant.
- c) The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report in respect of (a) & (b) above are received in her favour.
- d) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- e) If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order she shall forego her right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
- f) This order is issued in pursuance to rule 18(C) of S.O. 429 i.e Jammu & Kashmir Rehabilitation Assistance Scheme 2022 issued vide notification dated:- 06.09.2022.

This order is, however, subject to outcome of writ petition(s) if any, pending in any competent Court of Law.
