In case the employees availing the benefit shall give an undertaking to the effect that as and when he/she becomes due for functional promotion he/shc will not refuse
- That no higher standard pay-scale shall be granted to the employee who is under suspension on the date of 3. eligibility or who is charge-sheeted under provision of J&K classification control and appeal rules or any other rules for the purpose.

That the present In-Situ promotion shall not change /affect the existing designation/seniority/duties of the employees.

That such period of leave without allowances, as had not been agreed to by the competent authority to be counted for purpose of annual increment shall not be taken in account for reckoning of the period of 9/18/27 years for Higher standard pay-scale as the case may be.

That the benefit of promotion shall not be given to such employee, who relinquishes promotion for any reasons, what so ever.
