Sub: Transfers/Adjustment of Masters

Order No. 466 -DSEJ of 2016
Dated 31.08.2016

Whereas, some lecturers/Masters and Teachers of all districts except Jammu District were transferred/deployed and attached in District Jammu on various grounds; and

Whereas, due to this transfer and deployment the Surplus staff sitting in Jammu city and on the other hand there is a deficiency of teaching staff in District Doda, Kishtwar, Udhmapur, Ramban, Poonch , Rajouri, Kathua, Samba and Reasi; and

Whereas, future of students in such districts is at stake and an irreparable loss is being inflicted upon them due to personal interest of employees who compel authorities on one pretext or another vis-a-viz Health/ medical/ social/ family etc issues, for their posting in Jammu District which is not otherwise required; and


Whereas, needless to mention that a huge number of teaching staff of Jammu Division remain representing department for their posting in Jammu District on above grounds. Subsequently, when reverted to their parent district (except Jammu district) they obtain interim directions from Hon'ble Courts and continue to remain in Jammu district as surplus rendering precious human resource useless for the deptt., at the peril of naive student's future; and

Whereas, main purpose of School Education Department is to ensure that the students who are the main asset of our country, are imparted education which is promised by the Constitution of J&K State and India. As such, the lecturers/ Masters and Teachers engaged by the Govt. for the purpose shall have to serve at the places where department needs their services in the larger public interest; and

Whereas, Article 21 (a) of Indian Constitution provides as under:-

"21A. The State shall provide free and compulsory education to all children of the age of six to fourteen years in such manner as the State may, by law, determine."

Whereas, the Constitution of India under Directive Principle contained in article 45, has 'made a provision for free and compulsory education for all children up to the age of fourteen years within ten years of promulgation of the Constitution.



Whereas, it is not possible for the administration to achieve the goal of a literate and educated society unless the staff engaged by the Govt. for the purpose abides with the orders issued by the administration, in the larger public interest; and


Whereas, it has been observed that a number of such Masters and Lecturers of all Districts are working in Jammu district including some of them since 2004. Even some of those working outside are representing for a chance to work in Jammu; and

Whereas, unwanted transfer/deployment and attachment of staff from other districts(except Jammu district) leads to mass posting of teaching staff of Jammu district to other districts who in turn resents the same and keeps approaching this office for repatriation/cancellation of orders/ attachments/ deployment through representations, court directions thereby diverting the energy, which otherwise could have been utilized for promulgating policies for betterment of students, institutions and staff itself; and

Now therefore, in view of the above mentioned facts and circumstances the teaching staff whose name figures in the **Annexure-A** to this Order are hereby transferred with the directions to report their place of posting, **in the public interest** and in similar manner masters from other districts are being given an equal opportunity on rotation basis to work in Jammu District. In case, post has been filled up, concerned CEO shall adjust him/her suitably as per requirement of staff. Besides, CEO concerned shall also ensure that attachments/deployments for longer period are disposed-with, in view of transfer policy and relevant orders/instructions/circulars issued from time to time.

Their salary of August, 2016 to be drawn in the month of September, 2016 shall be drawn only from their new place of posting, after completion of codal formalities under rules.

The officials in the **Annexure-A** shall be deemed to have been relieved from the date of issuance of this order.
