**Sub: Non-Compliance of transfer Orders.**

**ORDER**

Whereas, the following Senior Assistants of District Doda were transferred vide this office Order No:857-DSEJ of 2016 dated 17-02-2016; and,

- 1) Talib Hussain, SA under orders of transfer from HSS, Doda to ZEO Bhatyas.
- 2) Raiz Ahmed SA under orders of transfer from HSS, Dossa to ZEO Ghat.
- 3) Irshad Ahmed SA under orders of transfer from ZEO, Doda to ZEO Bhagwah.

Whereas, it was reported by the Chief Education Officer, Doda that the above mentioned Sr. Assistants did not join their new place of postings; and,

Whereas, a notice was issued from this office vide No: DSEJ/NG/65747-59 dated:24-02-2016 for all officials to assume duties within two, <sup>days</sup> failing which action shall be taken in terms of civil services rule 1956; and,

Whereas, Chief Education Officer, Doda vide No: CEOD/NTS/6456 dated 02-06-2016 has again reported that inspite of warning notice, the above mentioned Sr. Assistants have not joined their new place of postings till dated; and

Whereas, the Principal, Govt. Higher Sec. School (Boys) , Doda has reported that Sh Talib Hussain, Sr. Assistant has been retained in BHSS ,Doda and Sh Raiz Ahmed Sr. Assistant has been retained in DDC office Doda vide District Development Commissioner, Doda order No: DDC/Edu-Corsp/14529-32 dated 29-02-2016; and,

Whereas, the said Principal Boys Hr.Sec.School, Doda has admitted that this action of District Development Commissioner, Doda was under taken on his request.

Whereas, the said Principal Boys Hr.Sec.School, Doda has again not followed the instructions issued by this office vide order No: DSEJ/NG/15352-53 dated 06-06-2016.

In view of the above, it has been observed that the said officials are not serious about their duties as per service conduct rules and are liable to be punished under law. Therefore, in terms of Rule 31 the above mentioned Sr. Assistants are hereby placed under suspension with immediate effect. Besides this, the Salary of Principal, Govt. (Boys) Higher Sec. School, Doda is being kept withheld till further orders in view of defiance of order issued by this office as well as showing complete disregard to the directions issued by the Govt from time to time.
